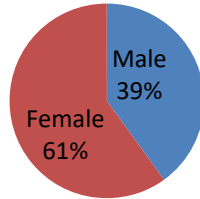

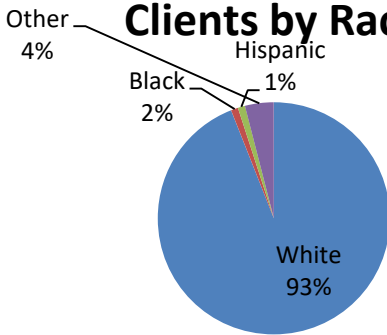
Who We Served

Cornerstone served 1829 clients in FY2017. Key demographics of the clients we served are:

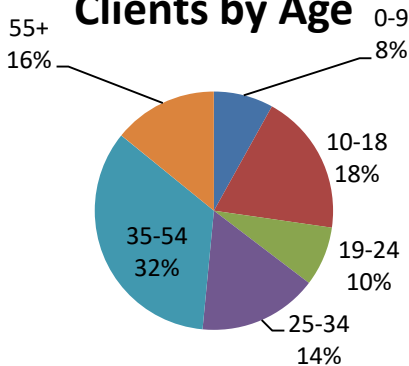
Clients by Gender



Clients by Race

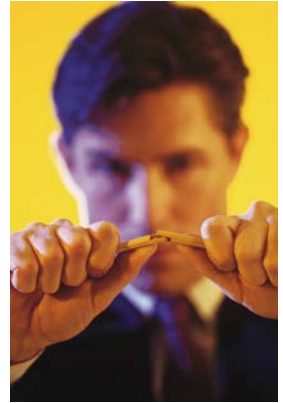


Clients by Age



Counseling Services

Cornerstone provides counseling services to individuals, families, and children. Our therapists employ a *Client-Directed Outcome-Informed* approach to treatment. This simply means that we utilize the client's feedback to direct therapy, and we monitor progress from session to session. Most clients will see positive change within the first three sessions.



Our **Comprehensive Youth Services** program provides counseling services to children under the age of 18 who have social, emotional or behavioral problems. Many of these services are provided within schools, where children who might not otherwise be able to come to the office can still receive services. CYS served 144 children and their family members.

The **Employee Assistance Program** serves local companies who have contracted with Cornerstone to provide short-term counseling services to their employees and dependent family members. Cornerstone also contracts with several national EAP providers. 118 clients received EAP services in FY2017.

Intensive counseling and case management services are provided to families with adopted children through the **Adoption Preservation Program**. The goal of this program is to help adopted families resolve conflict and reduce stress in order to keep the family intact and the adoption placement stable. Services are provided at no cost to adoptive families through a contract with the IL Department of Children & Family Services. This program served 172 individuals last year.

Cornerstone is a Preferred Provider for most insurance plans.

Thanks to support from the United Way of Adams County, we are able to provide services on an ability-to-pay basis using a sliding scale formula for individuals without health insurance. 44 individuals qualified for sliding scale assistance in FY2017.

76% of counseling clients reach their treatment goals in less than seven sessions.
The average length of treatment is three and one-half months.

Casework Services

Cornerstone offers two unique programs that provide support services to families who meet eligibility criteria established by state funders. A description of these programs and their target populations include:

Extended Family Support is a short term service to help relative caregivers obtain legal guardianship of children in their home. This enables caregivers to act in the capacity of a parent in the absence of the parent. This service is provided through a contract with the IL Department of Children & Family Services. The program provided a stable living arrangement to 14 children last year.

First Steps is a home-visiting program for new parents. It promotes positive parenting and child health and development through the first five years of a child's life. The program is available to families for first or second births. The program is funded by a contract with the IL Department of Human Services and is offered at no cost to families. First Steps served 103 individuals in FY2017.



100% of First Steps children kept their immunizations and well-child visits current in FY2017.

Psychiatric Services

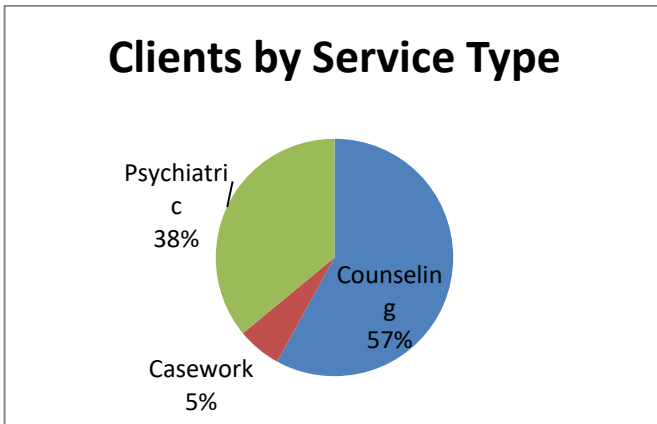
Working under the supervision of Dr. Carolyn Seifert, Reggie Westhoff, APN, provides psychiatric evaluation and medication management to individuals of all ages.

Reggie treats a broad range of psychiatric issues including Attention Deficit/Hyperactivity Disorder, anxiety, depression and bi-polar disorder.

687 people received psychiatric care at Cornerstone last year.

Client Services by Type

Adoptive Family Learns to Connect

Cornerstone has had the privilege of serving the Schuering family with ASAP services, and as Pam Schuering says, “Anybody who has adopted a child should be here. They just may not know it yet. Our eyes are not trained to see the signs of trauma.” The Schuerings had had their little son Daniel home for about a year and a half, and weren’t quite yet connecting as they had hope and prayed for. Daniel was showing some behavior that they did not understand, and they didn’t yet have the resources and

knowledge they needed to help him. That’s when a dear friend told them about Cornerstone, and about Trina. “Very shortly after we started meeting with Trina, we started to see healing. Really quickly,” says Pam. “With Cornerstone’s services we immediately had a greater appreciation and understanding of the great loss that Daniel had experienced. We started to understand some of his different and difficult behavior, and Trina gave us the simple tools to help us connect with Daniel, and create an environment where he felt safe. We started building a relationship where he trusted us and could receive all of the love that we wanted to give him.”

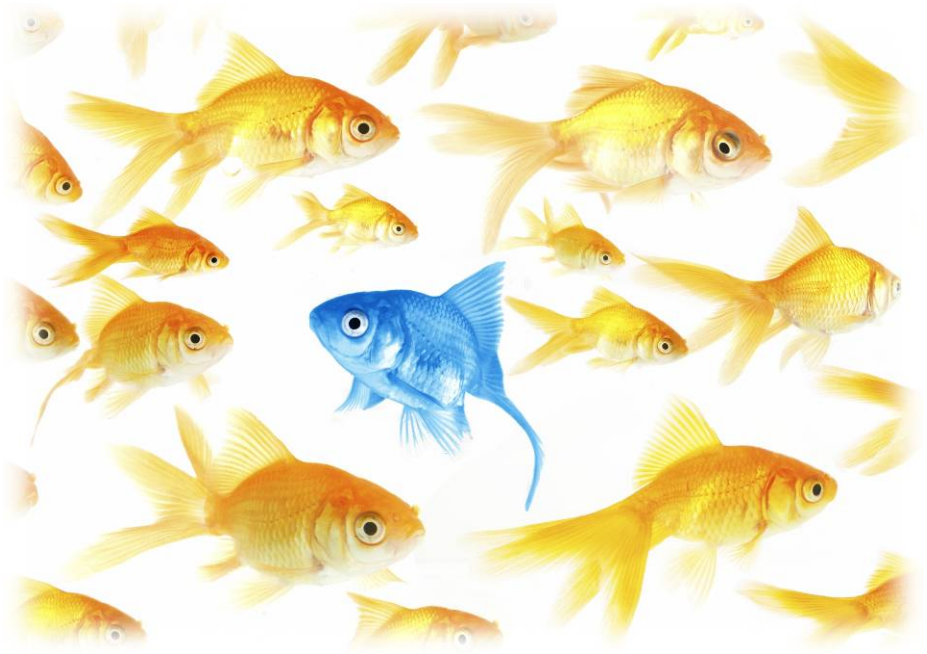
